### **RULES FOR ARTIFICIAL INSEMINATION FOR PART-BRED CLEVELAND BAY REGISTRATION**

The Cleveland Bay Horse Society (CBHS) encourages Part-Bred Cleveland Bay foals to be registered where the recipient mare has been inseminated by fresh, chilled or frozen semen provided that the following rules are strictly adhered to:

#### **1 The Donor Stallion**

The donor, if a Pure or Part-Bred Cleveland Bay stallion, as with natural covering, must meet all the requirements of the CBHS for natural service in that it must be:-

- Registered with the CBHS and be licenced for Pure or Part-Bred breeding.
- Have its DNA analysed and the results recorded in the CBHS records.

If a non-CBHS (licenced) stallion is used then the criteria of the relevant Breed/Registration Stud Book for that Stallion must be met and complied with. The stallion must be approved or licenced for breeding by the relevant Breed/Registration Society or Organisation.

#### **2 The Semen**

The semen used in the insemination must be certified as being the semen of the named donor stallion by a Veterinary Surgeon, or such competent person permitted by law in the country where the insemination occurs (see Part B of the AI Certificate).

#### **3 The Mare Owner**

The Mare owner must also certify that the semen is from the donor stallion to the best of his/her knowledge and belief.

#### **5 The Progeny**

Any resulting foal may be eligible for registration in the Part-Bred Register of the Cleveland Bay Horse Society providing the rules of entry are satisfied. *(The progeny of a Part Bred Licenced stallion will be eligible for registration in the Part-Bred Register ONLY if at least one great grandparent is entered with a name and a number in the CBHS Pure Stud Book).*

#### **6 Registration**

All such registrations must be submitted on the CBHS Part-Bred Registration form and accompanied by the Society's fully completed AI certificate.
