### **GUIDANCE NOTES FOR DUPLICATE PASSPORT APPLICATION**

This is an application for a Duplicate Passport where the original passport was issued by the Cleveland Bay Horse Society. By law a Duplicate Passport will be stamped as a Duplicate and will be signed as Not For Human Consumption. The Cleveland Bay Horse Society (CBHS) will issue a Duplicate Passport if the horse can be identified (from microchip number or a properly completed outline diagram). Owners requiring a Duplicate or Replacement passport must complete an application form and a veterinary surgeon will need to confirm that all details describing the horse on the markings section are correct or confirm the microchip number of the horse.

***Is the lost passport pre-2016 issue (bound, not punched)?*** If yes, then you will need to ask your Vet to complete the Identification Chart (pages 3,4 and 5 of this document) below in full as the CBHS will need to issue a new style passport for your horse. The CBHS will need to match the new chart to that which is held on our records for the horse at the original time of registration, so we recommend giving as much information as possible regarding whorls, white, and any other unique markings. If the horse is microchipped, this will need to be noted on the form, and will make confirmation easier. (Please note it is now mandatory for horses in the UK to be microchipped, and we encourage the use of microchips for Overseas horses for ease of identification).

***Was the lost passport issued 2016 onwards (punched)?*** If yes, this is a new style passport, and the CBHS will require a declaration from the Owner (the form on the next page only) that the passport is lost/stolen, and also confirmation from a Vet of the microchip number. If the horse does not have a microchip inserted (non-UK/EU based horses), then an Identification Chart will need to be completed in order to match the animal to our current database.

**In cases where there is no microchip inserted, and it is not possible to identify the horse by cross-checking the completed Identification Chart, for Pure Cleveland Bays and Part-Bred Cleveland Bays (with DNA on file) a DNA hair sample will be required to be tested. All costs will be borne by the applicant.**

#### **IDENTIFICATION CHART – (for old style bound passports or non-microchipped horses)**

The identification chart must be printed on A4 (8.27" x 11.69") paper and completed by a Veterinary Surgeon. It must be completed neatly, as it will be copied directly into the passport, and record at least 5 identifying features enabling the animal to be positively identified if a microchip scanner is not available. If you are unable to find three whorls (simple or linear) then EU law requires the chestnuts to be drawn. The diagram and text must match. If there is any white that will enable identification where there is no microchip, please enclose photographs that will assist.

Please ensure you return all completed documents and the fee to the CBHS who will contact you if any further information is required.

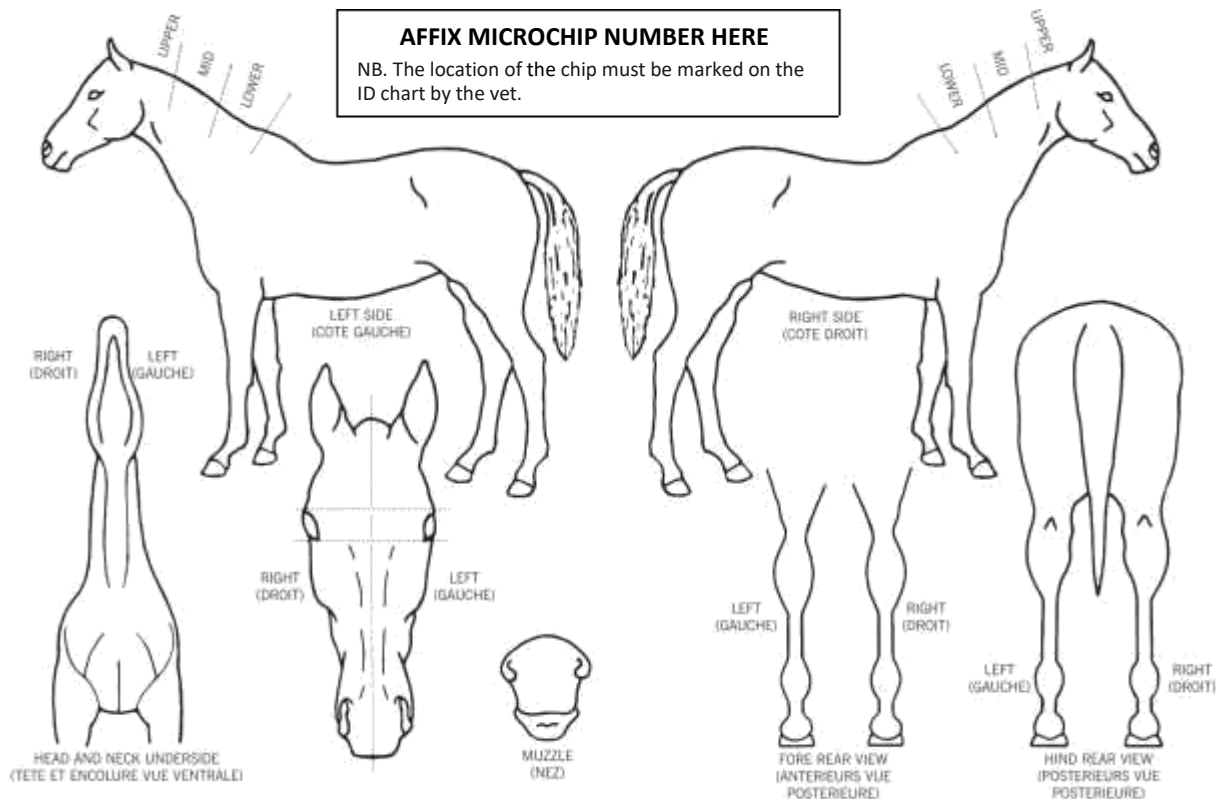
